

- Spoke with Luis Contreras about an incident during training hours yesterday morning.

RACES

Race 1 - All Clear

Race 2 – #2 Touch of Rouge (Steve Jadoo) broke slow. #8 Bettabe Swift (Eswan Flores) popped at the start. Race All Clear.

Race 3 - All Clear

Race 4 – Inquiry X 2 – Racing after the start and in the stretch.

- Inquiry #1 – Reviewed racing after the start between #1 Trilling Song (Leo Salles), #2 Buttered Toast (Skye Chernetz) and #3 Brienne of Tarth (Rafael Hernandez). Salles stated #2 was coming over and squeezed him on the rail; thought there may have been more pressure from the outside.

He also added he was lucky to not go over the rail when his horse hit it. Chernetz stated #3 put pressure on her and caused her horse to switch leads that put her onto #1. Hernandez stated his horse broke inward and he attempted to grab the horse to stay straight. The front tower shows #3 is coming down and putting pressure on #2, which is forcing her towards #1 on the rail. As a result of the pressure from the outside, #1 bounces off the rail. The Panel ruled #3 was at fault and subsequently disqualified from 4th to 10th. Will review film with Hernandez tomorrow.

- Inquiry #2 Reviewed racing in the stretch between #8 Sweet Bombolini (Emma-Jayne Wilson), #9 Grace On The Green (Justin Stein) and #10 Ready Candy (Keveh Nicholls). Wilson stated #9 shifted out and bumped with her horse, but also that her horse was running erratic. Stein stated he checked twice to make sure he was clear and did not think he bothered anyone. Nicholls stated there was a chain reaction and he had to check his horse. The video shows #8 is running erratic, as Wilson said, and appears to step in to #9, who also comes out slightly as both horses bump. #8 then goes out to #10 and forces Nicholls to check his horse. #9 is not at fault to warrant a placing from 4th (5th PL 4th from 1st Inq). No action needed.

Race 7 – Inquiry – Reviewed racing in the stretch between #2 Cardio Princess (Justin Stein) and #4 Sparkle Sammy (Rafael Hernandez). Stein stated #4 was tiring and he had room to move out. Hernandez stated his horse was all done and overreacted; he was not interfered with. The Panel ruled there was no interference by #2 on #4; no change.
