**Race 3** – Reviewed racing in the stretch between #3 Shishka (Micah Husbands) and #6 Linda Loves Lace (David Moran). #3 does not impede the progress of #6 in the stretch and no action was needed.

Race 6 – #8 Lobby Bar (Emma-Jayne Wilson) broke slow from the gate. Race All Clear.

**Race 7** – Inquiry – Reviewed racing shortly after the start between #2 Ever So d'Wild (Juan Crawford), #4 My Final Trick (Jason Hoyte) and #7 Swirling Candy (Keveh Nicholls). Crawford stated he got pinballed around between horses. Hoyte stated he was bumping with #2 and then clipped heels with #7, but his horse jumped up into a bad spot while trying to settle in between horses. Nicholls stated that he looked back and saw he was clear so began crossing over. The Apex shot showed there is contact between #4 and #7. The low and pan video show that #7 appears clear of inside horses, but #4 takes off on Hoyte and runs up on #7. #2 is forced to check hard to the inside of #4. #4 finished sixth behind both horses and no placings were necessary.

**Race 8** – Inquiry – Reviewed racing around the turn between #5 Snookered (Steve Jadoo) and #6 Solis (James Chau). Chau stated he moved out to go out around #1. The video shows #6 moves out and is not clear of #5, which causes #5 to stumble and unseat rider Jadoo. #6 finished 5<sup>th</sup> and was placed 8<sup>th</sup> and subsequently disqualified.
