## **STAND**

- Trainer Alexander McPherson was offered and accepted a settlement agreement for a Class 5 Positive Test for the drug Cimetidine on the horse Candy's Dream in Race 7 on September 24. Mr. McPherson was assessed a \$500 monetary penalty. The horse Candy's Dream is hereby declared unplaced for all purposes except pari-mutuel wagering. AGCO Rules 15.03.01(a), 15.04.03, 15.06.03(c), 16.13(d), and 24.04 apply. Ruling #1407401.

## **RACES**

Race 1 - Inquiry - Reviewed the start of #7 Broadway Sky (Daisuke Fukumoto). The front tower video shows #7 did not receive a fair start and therefore was refunded for pari-mutuel purposes. Refund \$23,635.

- Reviewed racing going into the turn – #2 Pot Committed (Keveh Nicholls) appears to come down and cause interference to #1 Laraque (Antonio Gallardo) and #3 Hagemeister Park (Justin Stein).

Race 2 – JCOF – #3 Executive Search (Gary Boulanger) on #4 Mason's Gamble (Patrick Husbands) in the stretch. Mr. Boulanger felt #4 came down and interfered with him. The front tower video shows #3 initiated the contact and #4 was not at fault. JCOF disallowed.

Race 3 – JCOF & TCOF – #2 Sir Winston (Antonio Gallardo) on #5 Special Forces (Justin Stein) in the stretch. Also, a Stewards Inquiry involving #4 Halo Again (Shaun Bridgmohan). Bridgmohan stated his horse stepped out when he moved his crop from his right to left hand. The front tower video confirmed Bridgmohan's statement and shows that #4 initiates the contact with #2. #5 is to the outside of both horses and not at fault. As #4 finished 3<sup>rd</sup> behind both horses no change was made to the order of finish.

Race 4 – JCOF – #2 Silver Dahlia (Eswan Flores) on #5 Hello Friends (David Moran) at the 5/8ths. After reviewing the video and speaking to Jockeys Flores, Moran and Luis Contreras (#8 Reinforced), it was determined that #9 Imagery (Kazushi Kimura) on the outside crossed over and put pressure on inside horses. This caused interference to #2, 5, and 8, forcing them on heels and to check up. JCOF disallowed as #5 was not at fault. No change was needed as #9 finished 7<sup>th</sup>.
