Juan said his horse was shying from Sophia Vives horse to the outside, said the more he pulled on him the harder the horse tried to go in with him. Looked over a couple times, nothing I could do. Kazushi said he was yelling at Juan but he just kept coming over, got me and horses to my inside, we were all in trouble. Amanda said she hit the fence from all the pressure from the outside, was in a bad spot. After review, It was decided that Juan be levied a five day calendar suspension for the incident, days to be determined.

Race 2 – Steward's Inquiry into the start regarding #5 "Courtingcourtney" ridden by Kazushi Kimura. The horse dwelt and the Starter Ian Ross said the filly is a problem and has done this

before. The horse did receive a fair start, no change.

Race 3 – Trainer Claim of Foul (COF) by Debra Rombis of #2 "Alcom'soutinthwash" ridden by Kirk Johnson against #1 "Rookie Court" ridden by Daisuke Fukumoto for interference leaving the gate. Kirk said the inside did come out and had to take a bit of a hold. Daisuke said his horse did go out but grabbed right away. After review, the COF was disallowed.
