Race 14 on Sunday July 30, involving Sky Chernetz and Leo Salles on the Clubhouse turn. Guild rep. Daren Gomez and Jockey Rafael Hernandez were present. Skye said we were going into the clubhouse turn and I have room, Leo looked over at me twice then came in abruptly, putting me into the fence and I clipped his heels, I was lucky I didn't go down. It was very dangerous and feel it was done on purpose. Leo said he was on heels and had outside pressure, did everything he could to protect her, I was in a bad spot. After review, it was determined interference was careless and Mr. Salles did ride in an unsafe manner without due cause and warrants more than the standard three day penalty. Mr. Salles is hereby levied a seven-calendar day suspension, days to be determined. AGCO rule 9.25 Advised any future incidents similar in nature will be dealt with more severely.
