Film Reviews:

Yesterday's fourth race involving Sahin Civaci and Skye Chernetz during the stretch run. Jockey's Guild Rep Daren Gomez was present. Sahin said he had just dropped his stick and hand riding, saw Patrick to the outside and wanted to get next him to encourage my horse, didn't see Skye making a run in between, it was a mistake. Skye said her horse was full of run, was going to win when Sahin's horse came into my path and I had to check, stopped my horses' momentum. After discussion it was decided that a three-day suspension be levied to Mr. Civaci, days to be determined.

Race 5 review with Eswan Flores and the use of his crop during the stretch run. Review shows Eswan use his crop four times in succession. Eswan said his horse was laying in with him and just trying to keep him straight. This is a second offence which constitutes a \$300 fine and a one day suspension, day to be determined.
