Advised we reviewed the stretch run several times and felt there was no further interference other than what happened in late stretch.

Film Reviews:

Review of yesterdays seventh race interference in late stretch. Those involved were Leo Salles, Emma-Jayne Wilson and Skye Chernetz. Guild reps Larry Attard and Gary Boulanger were present. Skye said she had her path and felt she was going to win, had Emma to my outside when Leo came out and into my path. He just kept coming out and never tried to straighten his horse, was on his heels, cost me the win. Emma said she was outside Skye through the lane and keeping her path. Said if Leo doesn't come out in front of Skye, she probably wins the race. Leo said his horse was a first time starter and running green with him, switched his crop to his left hand and hit her once and she drifted out on me. After discussion, it was decided the infraction by Leo Salles warranted a three day suspension, days to be determined.

Races:

Race 1 - #6 "Street Max" ridden by Rachel Slevinsky was away poorly. No video replay available due to technical difficulties.

Race 2 – Stewards Inquiry into the start regarding #6 "Preetzah's Star" ridden by Jason Hoyte. Horse reared at the start hitting the doors and opening them early. A refund of mutuels was ordered and the horse was unplaced for an unfair start. Refund amount \$29,863.
